



RoHS Compliance Statement

The European Union passed the **Restriction of Hazardous Substances in Electrical and Electronic Equipment (RoHS) Directive** in January 2003. RoHS restricts the use of certain hazardous materials found in electrical and electronic products.

The RoHS directive is updated periodically with the latest revision RoHS-3 Directive (2015/863/EU) on July 22, 2022. The current list of restricted substances include:

- **Cadmium (Cd):** < 100 ppm
- **Lead (Pb):** < 1000 ppm
- **Mercury (Hg):** < 1000 ppm
- **Hexavalent Chromium: (Cr VI)** < 1000 ppm
- **Polybrominated Biphenyls (PBB):** < 1000 ppm
- **Polybrominated Diphenyl Ethers (PBDE):** < 1000 ppm
- **Bis(2-Ethylhexyl) phthalate (DEHP):** < 1000 ppm
- **Benzyl butyl phthalate (BBP):** < 1000 ppm
- **Dibutyl phthalate (DBP):** < 1000 ppm
- **Di isobutyl phthalate (DIBP):** < 1000 ppm
